- Judge Carlos Armour (Republican) appointed by former governor Arnold Schwarzenegger on July 21, 2008. Armour was re-elected in 2010 by running unopposed and his current term will expire in 2017 - automatically re-elected by running unopposed in 2016.
- Judge Blaine Bowman (Republican) elected to the bench in June 2008 to a term commencing in January 2009; however, on July 21, 2008, former governor Arnold Schwarzenegger appointed Bowman to the bench allowing him to immediately assume the position. Bowman succeeded Edward Huntington. He filed for re-election in 2014, but due to facing no opposition, was automatically elected to a new term that expires in 2021.
- Judge Ana Espana (Democrat) appointed by former governor Arnold Schwarzenegger on July 21, 2008 to succeed Janet Kintner. Espana was re-elected in 2010 when she ran unopposed and her current term will expire in 2017 – automatically re-elected by running unopposed in 2016.
- 4. Judge Eugenia Eyherabide (Republican) appointed by former governor Arnold Schwarzenegger in February 2006 to succeed William C. Pate. Eyherabide was most recently re-elected in 2012 when she ran unopposed and her current term will expire in 2019.
- 5. Judge Michael Groch (Democrat) appointed in December 2010 by former governor Arnold Schwarzenegger to succeed Yuri Hofmann. Groch was automatically re-elected in 2012 and his current term will expire in 2019.
- 6. Judge Louis Hanoian (party unknown) appointed to the Superior Court in 1998, filed for reelection in 2014, but due to facing no opposition, was automatically elected to a new term that expires in 2021.
- 7. Judge Sim Von Kalinowski (Republican) appointed by former governor Arnold Schwarzenegger on July 21, 2008. Von Kalinowski was re-elected in 2010 when he ran unopposed and his current term will expire in 2017 automatically re-elected by running unopposed in 2016.
- 8. Judge Robert Kearney (Republican) appointed by former governor Arnold Schwarzenegger on July 21, 2008 to succeed Lillian Lim. Kearney was re-elected in 2010 by running unopposed and his current term will expire in 2017 –automatically re-elected by running unopposed in 2016.
- 9. Judge K. Michael Kirkman (Republican) elected to the bench on June 2, 1998. Kirkman was most recently re-elected in 2010 when he ran unopposed and his current term will expire in 2017 automatically re-elected by running unopposed in 2016.

- 10. Judge Dan Link (party unknown) appointed by Governor Jerry Brown on July 16, 2014, to replace Richard E. Mills. He must face his first election in 2016 to retain the seat automatically elected by running unopposed.
- 11. Judge Michael Popkins (Democrat) appointed by Governor Jerry Brown on May 21, 2013. The only sitting judge co-sponsoring the fundraiser for Greer-Katz and Mangione to have been reelected by voters. He competed in the primary on June 3, 2014 and was re-elected to a term which expires on January 4, 2021. His challenger, Paul Ware, is running against James Mangione in 2016. Judge Popkins is fundraising for Judge Mangione in his first judicial election.
- 12. Judge Lisa Rodriguez (party unknown) appointed by Governor Jerry Brown (D) on March 27, 2015, to fill the vacancy created by the retirement of Susan D. Huguenor. She was sworn in on April 2. Her term expires in 2017 automatically elected by running unopposed in 2016.
- 13. Judge Polly Shamoon (Republican) appointed by former governor Arnold Schwarzenegger on July 21, 2008 to succeed Larrie R. Brainard. Shamoon was automatically elected in 2010 by running unopposed and her current term will expire in 2017 automatically re-elected by running unopposed in 2016.
- 14. Judge Rod Shelton (party unknown) appointed in 2006, ran for re-election to the superior court in 2012. As an unopposed incumbent, his name did not appear on the ballot. After the primary election, Shelton was automatically re-elected.
- 15. Judge Robert Trentacosta (party unknown) filed for re-election in 2014, but due to facing no opposition, was automatically elected to a new term that expires in 2021.
