I received your twenty-six page letter dated September 11, 2011 with its attachments, indicating your dissatisfaction with the various rulings made by judicial officers in your above-referenced cases, and asking me to make certain corrections in the record.


It appears that each and every date for which you request written confirmation (page 24) stems either from a judicial order I cannot review, whether or not it is erroneous, and/or from your own filings. My duties as Executive Officer are set forth in California Rules of Court, Rule 10.610. The rule does not permit me to review the orders rulings of judicial officers of this court, and certainly, do not provide for my review of orders, decisions or actions of the Court of Appeal or the Supreme Court.

Specifically:

- On January 7, 2009, the Honorable Joel Pressman, Judge of the Superior Court of California, County of San Diego ("Superior Court") ordered that an amended judgment had been entered in this case on December 18, 2008 (Attachment A).
- On January 14, 2009, you filed a Notice of Appeal from orders made on December 12, 2008 (Attachment B). As such, your own appeal memorializes that date. On January 28, 2009, the Clerk of the Superior Court filed a Notice of Filing from a Judgment/Order of December 12, 2008 (Attachment C).
- On January 27, 2009, the Honorable William Dato, Judge of the Superior Court, denied your ex parte request for "Clarification and Verification of Judgments, Dates of Entry and Notices of Dates of Entry (Attachment D). In your ex parte Application filed January 23, 2009, you provided as Exhibit 1 to the application, a Judgment signed by The Honorable Lisa Schall, Judge of the Superior Court on September 24, 2008; and as Exhibit 2, a copy of a Minute Order on December 12, 2008, wherein Judge Schall ordered that Notice of Entry of Judgment was properly served on you on October 16, 2008 (Attachment E).

Your additional concerns about the Case History portion of the Court Case Management System were addressed in a letter to you dated October 5, 2011 by the Honorable Kevin A. Enright, Presiding Judge of the Superior Court.
