Sharon Kramer, Dr. Ritchie Shoemaker and I met with you on March 20th. We discussed mold and Department of Defense housing for military families. I promised to send you a bibliography of articles supporting how mold in buildings can cause multi-system illness in people. I apologize for the delay, but I have now attached a comprehensive list of all epidemiologic articles pertaining to mold and adverse human health effects published in the peer-reviewed literature between 2011 and 2018.

In sum, there are 116 articles in total. The articles which support are 114 in number, there are only 2 non-supportive articles. Individual system damage is also supported. Thirty articles support general system illness (fatigue, headaches, sleep problems, etc.) There are no articles which are not -supportive of general system illness. Please see the table immediately below.
