Dear HHS General Counsel Bagenstos and HHS OGC receptionist Andre Jones,

Andre, thank you for taking my calls beginning last Thursday and accepting my emails regarding this matter. I appreciate you forwarding them to the communications department of HHS.

However, this matter requires prompt attention from high authority at HHS, which is why I reached out to the Office of HHS General Counsel. If you could please forward my emails to Mr. Bagenstos and tell him some of what I have told you orally, it would help greatly.

I am going to forward the four emails to Mr. Bagenstos, too, in additional emails to this one.

Mr. Bagenstos, I am a brutally retaliated against environmental health policy and court reformer. Secretary Becerra knows who I am.

Our paths first crossed six years ago when he was Governor Brown's newly appointed California Attorney General in February of 2017.

At the time, he had prosecutorial jurisdiction and ability to stop my brutal retaliation under the facade of law -- for telling the truth about corruption in HHS and associates' policies.

The way that we met, was by me walking into a room filled with California judges and justices, naming several of them and asking Secretary Becerra to cause a criminal investigation of them -- along with also-named HHS environmental policy deformers as beneficiaries of judicially case-fixed SLAPP suits as plaintiffs.

While being video recorded Secretary Becerra said I could have a "*department of justice*" and "*my office*" investigation of his former fellow officers of the California courts and the HHS environmental policy deformers/SLAPP plaintiffs --later.

I knew that the words were placatingly disingenuous as soon as he said them. This is because in the very next breath, he turned around sold doubt about everything I said with "*harmless error*" quips; without asking me even one question.

Then he voted to appoint Brown's appellate justice nominee to be Associate Appellate Justice William DATO in the Fourth District Division One Court of Appeals (Fourth/First).

I had just explained both orally and in writing to Secretary that Judge (now Justice) DATO is material to the corruption remaining viable in HHS policies via remaining material to framing me as libeling HHS's policy deformers with fraudulent court documents, and with no accountability.

So, I know that Secretary Becerra has superior knowledge of this matter, because he was forced to personally hear and read about it as a vetting-before-voting panelist of the Commission on Judicial Appointments (COJA) in February of 2017.

And I also know that as HHS Secretary he owns the key disinformation to a massive HHS backed disinformation machine, I.e. that I am an ignorant woman who complains of "*extremely harmless errors*" that are not criminal and harm no one.

It was bad enough when he was California Attorney General. But now that he is HHS Secretary his "*harmless error*" quips are literally deadly until he apologizes and gives me the "*department of justice*" and "*my office*" investigation that he already said that I may have (while being video recorded).

### **THE PROBLEM SECRETARY BECERRA'S "*HARMLESS ERROR*" JOKES ARE CAUSING FOR ME TODAY.**

Even though I have been framed for libel in California since 2005, I still remain an environmental health policy and court reformer. I am not without friends in government.

I keep in touch with the GAO auditors who are auditing the PPV military housing debacle. I have for years.

Currently, the Senators of the Permanent Subcommittee on Investigations (PSI) are trying to get to the bottom of why DOD's data base regarding the maladies caused by contaminated military housing is so hazardously lacking.

I sent an email to a contact at GAO last Wed asking if it would cause a problem for them, if I told the Senators what GAO already knows about DOD just parroting HHS -- who lets the expert defense witnesses for the insurers of moldy military housing use false science to set the HHS policies. (two of them are also the plaintiffs in the SLAPP suit that Secretary Becerra has pledged to investigate)

This is the root cause of the landlords and their property casualty insurers being able cheat to avoid liability for causation of the military families' disabilities caused by biocontaminated water damaged military housing. (biocontaminated --meaning mold,

mycotoxins bacteria, etc. along with biotoxins -- lay terminology "toxic mold").

The GAO knows that I am telling the truth about DOD parroting HHS that parrots the military housing landlords' expert defense witnesses and promotes it as so called "evidence based current accepted science". I have shown GAO the details of how the scam works via HHS and associates promoting debunked science of the expert defense witnesses. I have taken physicians with me to the GAO, too.

GAO has been doing an incredible job when trying to help the military families. GAO stand ready to help expose that HHS also plays a key role in the matter.

All they need is directive to audit by SCOPE -- *Who* is promulgating the standards at HHS, HOW erred directives get into the DOD data bases, HOW this is then used in mold litigations to cheat the families; and WHO has conflicts of interest that enables this to continue.

I don't want to tell the senators of PSI, that Secretary Becerra owns the problem via making fun of me when I came to help six years ago, and he said he would investigate later; and all that they must do is ask GAO questions that GAO already knows the answers too.

I have been fighting along side others for nineteen year to stop HHS from allowing medico-legal expert defense witnesses for the insurance industry and government departments to run the game in the mold issue. (including two who are SLAPP plaintiffs in California SLAPP plaintiffs,who Secretary Becerra has already pledged to investigate)

Eighteen of those years of my advocating for the cheated, discriminated against and less fortunate; the California courts have been used as a weapon to frame me as libeling HHS's policy deformeders -- to make me falsely appear to be an ignorant woman and a legally proven malicious liar who complains of "*extremely harmless errors.*"

Its true. I do view Secretary Becerra as an extremely dangerous flat earther regarding this matter because of what happened when our paths first crossed. [dangerous flat earther -- adds to a HHS backed disinformation machine via making up an absurd excuse on the fly for California jurists who systematically frame an exposor of scientific fraud in HHS policies for libel. Laughs and votes to appoint one of the jurists to be an appellate justice; says he will investigate the jurists and HHS policy deformeders later. Does not follow through on the pledge. Is then appointed HHS Secretary to the detriment of evidence-based science in environmental policy setting; and the health and safety of a marginalized class of the herd. And scares the exposor that she is going to be **physicially hurt again** for trying to get through to him how the became a dangerous flat earther HHS Secretary, and why he needs to stop being one.]

But I also know that he really does work to try to stop discrimination for marginalized classes of people. If Secretary Becerra understood what he was making fun of and pledging to investigate later, he never would have made that remarkably obtuse speech

that he did on February 9, 2017 (particularly because a camera was rolling). I don't believe that he wants to continue to own this problem that is devastating the lives of so many.

Please help me help the People, Mr. Bagenstos. This problem is not going to go away by sweeping it under the rug with "*harmless error*" jokes. Neither am I until the fraudsters involved are held accountable -- so they can harm no one else in the future -- including me for my continued telling of the truth in America.

I don't want to go to the PSI senators. I'm afraid it will just turn into a political fight about who is at fault, and nothing will change for the families.

That's how it has been for over twenty years! The late Congressman Conyers was the first to try and stop the gov't backed fraud in the mold issue beginning in 2002. It has just gotten worse and more deeply entrenched.
